1) <u>Roll Call</u>

a. Meeting called to order at: 10:06am by: Terry Hall, Chair

2) Introductory Remarks

- a. Shawn Talmadge, VDEM State Coordinator, gave an introduction about himself and the impact the SWIC/SIEC had on the major storm in North Carolina and Virginia. Shawn gave an overview that included 136 Virginians were impacted directly from the storm. He included the importance of PSAP and the agencies that are able to operate seamlessly due to the group's leadership, roles and the work that is being done.
- b. Terry Hall, Chair introduced himself then opened up the floor for discussion.
- c. Region 4 update on Helene wide spread outages, Tazewell County having 80% capacity loss. Smyth County 1st hour of incident lost LMR system. Found communication issues outside of STARS and ComLinc. Smyth County lost approx. 40% of copper line. While everything worked out there were still issues that came up during this storm. Wanting to reevaluate and preform hot washes with local committee to move forward.
- d. Terry Hall and Shawn Talmadge continued into a conversation about grants. Mr. Talmadge discussed how the budgeting process works with grant funding. He discussed how VDEM goes to the federal level to achieve grant funding and then applies it back to the Commonwealth.
- e. VFCA- discussed the difference from 20 years ago today about the progress a success of communications for public safety.

- f. Multiple people joined in the conversation to give credit to the first responders, emergency services, and rescue resources from the flooding and tragedy that Southwest Virginia experienced in September of 2024.
- g. [unknown voice] Explained his perspective of the events from the storm Helene from Richmond; and how they sent out swift water teams and different rescue teams to aid in the effort to help the people of southwest Virginia.
- h. Gabe Elias, Statewide Interoperability Coordinator (SWIC) gave an overview of storm Helene. He proceeded to go over the environment successes, and lessons from the storm. He shared his gratitude for the statewide mutual aid that serves the regions in need.
- i. Terry Hall, Chair included his kudos to the multiple services that helped exceedingly in the efforts of the emergency services that provided for the storm Helene such as STARS and COMLINC.

- a. Dorothy Spears-Dean, Deputy State Coordinator, gave an update on the skill sets that the bureau offers VDEM and what they are able to offer statewide mutual aid. Dr. Spears-Dean continued to give an update on the NG9-1-1 technology and what is to come for Virginia.
- b. Mr. Talmadge left the meeting, VDEM Representative Mike Keefe Remained at the meeting.

7) State Updates

- a. VDEM Focus on the last 30 days has been Helene; leaning heavily into Starlink.
- b. VDH Still in process of upgrade for encrypted video with 50 more sites
- c. OEMS- Hopefully new director in January to begin to restructure.

- e. DMA- Ready to deploy kits for FEMA with exercises once a month.

- i. VSP Phase 5 ends Friday after 5 years; STARS cache deployed some radios and is going to be proactive to have a cache of radios for available in regions/divisions. Lessons learned: Verizon worked well for STARS; State police would like to have their own Cell on wheels to deploy when needed to obtain more assets. All STARS users will be able to talk on any mobiles and portables in the state.

a. RPAC-I Chairs Region 1 and Region 2 unable to attend.

- b. RPAC-I REGION 3 the calls were not at the regional PSAP other localities were having calls were going to different PSAPS across the state. Searching for resolutions for the routing problems.
- c. Region 4 all of the staff was involved with storm Helene. Has seen great response with everyone during this time
- d. Region 5 Working with Orion, hired consultant to go over a document and send it out. The Port of Virginia has STARS and that has opened up. There is lots of efforts and energy there to create compatible equipment. Noted inadequate Fleet mapping across Hampton Roads. The Region 5 struggles are very similar to other regions. Moving forward we need to place an emphasis on fleet mapping. Our successes are working together.
- e. Region 6- creating a strong group meeting on a monthly cadence to continue to build attendance. Building the interoperability. Regional teams how can we get on common channels on a tactical level. Asked questions about common channels being used on a tactile level, and what are other regions facing such as struggles, success, resources, and assets.
- f. Region 7 In the busy season, finished Marine Corps Marathon. We are going to push out new template for a new zone for regional interoperability. The days of handing out radios should be over. The NCR is been working with them twice a year. Encryption difficulty in Arlington.
- g. VA Communications Cache Large scale events need support and comm technicians. Still operating through scenarios and exercise. Developing training and exercises. Helping to create the future for applications and what those opportunities may look like. Deployable trunking sites are available.
- h. DHS CISA Volt Typhoon, preeminent cyber threat security to burrow into critical infrastructure. Ability to create a security for the emergency mode of communication. TA – Virginia approved for a

cyber-security tabletop. During Helene impact of fiber cut in Georgia. What are the effects of malware when all of us our connected. SAFECOM Survey went well with over 100 municipalities. Statistically valid. Deployable trunking, different scenarios being done by deploying simultaneously.
